Description of Project: The Saluda C.T.C. is seeking bids from qualified road contractors on the below listed work. A partial list of items include: mobilization, clearing, grubbing, removal & disposal of existing pipe and debris, placement of various size reinforced concrete pipe, back fill & compact, pipe size range from 24" to 84", approximate total of all pipe is 912 LF, hand placed rip rap and other items pertaining to this project. Contractor is to assume responsibility for all testing, staking, and engineering. A 10% bid bond is required. Scope of work and specifications can be obtained from the Saluda County Roads & Bridges Department. Checks for the bid packages should be made out to the Saluda County Transportation Committee. Completion date is 180 days after the award of the contract and a \$150.00 per day penalty is placed if work is not completed on time. The Saluda County Transportation Committee has the right to reject any and all bids.
