F. OLD BUSINESS

On motion of Councilman Bedenbaugh, seconded by Vice-Chairman Atkinson, Second Reading was unanimously given to Ordinance No. 10-23, "AN ORDINANCE APPROVING SALE OF REAL PROPERTY LOCATED AT THE SOUTHEAST INTERSECTION OF HIGHWAY 378

AND NORTH BOUKNIGHT FERRY ROAD IN SALUDA COUNTY, SOUTH CAROLINA TO PROJECT COMMERCE."

G. NEW BUSINESS

On motion of Councilman Bedenbaugh, seconded by Vice-Chairman Atkinson, the County Operating Millage for FY 2023-2024 was unanimously approved as follows: County Operating Millage at 147.3 Mills, Economic Development at 3 Mills, Law Enforcement/Detention at 12 Mills, Piedmont Technical College at 3.5 Mills, Public Buildings Maintenance at 3 Mills and the Fire Board at 4 Mills.

On motion of Councilman Bedenbaugh, seconded by Vice-Chairman Atkinson the millage for Saluda School District One was unanimously approved as follows: Operating millage at 166.9 mills and Saluda School District One Bond Mills: a total of 34.6 Mills.

On motion of Councilman Daniel, seconded by Councilman Anderson it was unanimously approved to award a bid to Kenrick Construction to build restrooms at Brooks Royston Park in the amount of \$66,435 to be paid from the Capital Project Sales Tax Account.
