Failure to receive a tax bill because of an incorrect address or change in ownership will not result in the waiver of incurred penalties.

The tax bill should be presented when making the payment.

If an escrow account is involved and the mortgage company requests the tax bill for payment, the tax information will be supplied to the mortgage company and a copy mailed to the property owner. It is the property owner's responsibility to see that the tax bill is paid by the mortgage company and / or the property owner.

All tax payments are due and payable without penalty by close of business on January 15, 2025. Appropriate penalties as shown on the tax bill will be assessed and collected as a part of the total tax bill after January 15, 2025. No partial payments will be accepted. Tax payments bearing a United States postal stamped date of January 15, 2025, will be accepted without penalty.

When the due date falls on a Saturday, Sunday, or legal holiday, the due date is extended to the next business day. A legal holiday is any day the Courthouse or the offices of the United States
Postal Service are closed.
