The following dates and times are hereby established for the nomination and election of candidates for Town Council in the November 7, 2023, municipal election.

This is a nonpartisan election and no party affiliation shall be placed on the ballot.

Any person wishing to vote in this election must register online no later than Sunday, October 8, 2023. In person registration deadline is Friday October 6, 2023. Voter Registration by mail forms will be accepted if postmarked by Monday, October 9, 2023.
